### **PRIVACY POLICY**

### Who can access your personal information?

In addition to the processing manager, access to personal data may be held by third parties who assist us in providing technical support such as platform or hosting providers, database support and maintenance, as well as software and applications that may contain your data (such services sometimes involve permitted access to your data in order to perform the necessary tasks).

## The place where we store your personal information

The data collected are stored and processed within the European Economic Area ("EEA").

#### How long do we store your personal information?

We only store your personal information for as long as we need it for exactly the purposes for which we store it in the first place, in order to meet your needs or legal obligations.

To determine the retention period, we are guided by the following criteria:

if you contact us with an inquiry, we store your personal information for the period necessary to process the inquiry; if you have agreed to direct marketing, we store your personal information until you unsubscribe or request that you unsubscribe.

When cookies are stored on your computer, we store them as they serve a purpose (e.g. for the duration of the cookie basket session or cookie ID) or for the duration specified in local regulations and guidelines; we may retain some of your personal information for the purpose of fulfiling your legal and regulatory obligations, as well as for the purpose of managing your rights (for example, accomplishing rights in the courts) or collecting statistics and keeping records.

When we no longer need your personal information, we remove it from the system and archives or turn it into anonymous data so that we can no longer identify you.
